Allowable activities have included assisting participants with completing admissions and financial aid forms and providing tutorial services. Program serves primarily low-income, first-generation students. In FY 06, about \$48.9 million may be available to fund up to 140 awards.

**ITEM:** Funding available for organizations to provide training to assist law enforcement officers, prosecutors, and relevant officers of Federal, State, tribal, and local courts in recognizing, addressing, investigating, and prosecuting instances of elder abuse, neglect, exploitation, and violence against individuals with disabilities, including domestic violence and sexual assault, against older or disabled individuals. In FY 06, approximately eight to ten awards will be made for up to \$450,000 each. Applicants must register for Grants.gov by 1/26, applications due February 16.
