Bias Motivated Incidents Report Discussion

- A total of twenty-five incidents were reported during spring 2008, compared to thirty-three reports for summer/fall semesters, 2007.
- Twenty-three reports received were from the University Park campus; one report received was from the Shenango campus; and, one report was from the Scranton-Worthington campus.
- When it was possible and if the submitter provided contact information, each case submission was followed up with a contact by the Diversity Advocate. In a few instances, the targeted person was encouraged to make an additional police report. Where the perpetrator was known, contact with that individual or that individual's supervisor was made. In one instance, a Muslim student leader was harassed via e-mail on two separate occasions. Since the incidents were similar and occurred with the same individual and his student organization, the Muslim Student Association, the occurrences were counted as one incident. Police involvement did occur and one of the perpetrators was contacted by police and warned. The point of origin is known for only one of the perpetrators.

The Centre County district attorney determined that since the comments made by the perpetrator in the second instance were more generic than specifically directed to the student, no special action to determine the point of origin was made at the time, nor was the e-mail considered a threat.

However, the Muslim Student Association did consider the e-mail a threat, especially in the aftermath of the publishing of a political advertisement in the *Daily Collegian*. The negative advertisement, paid for by the Terrorism Awareness Project, a project associated with **David Horowitz, made some erroneous accusations, which the Muslim Student Association felt would provoke others to do harm to their members or to Muslims in general.

- As always, confidentiality of identities and information will be respected, unless otherwise indicated by the submitter or targeted person.
- Multiple categories often exist for the status of Targeted Persons, Race/Ethnicity, Targeted Issues, and Types of Offense. An effort is made to indicate one choice, and which best describes an incident or individual, or how that individual may identify themselves. However, in some instances where appropriate and where overlap exists, more than one category is chosen and indicated. This accounts for the occasional slightly higher numbers within a category than the total number of reports given. In addition, two perpetrators may have acted in concert.

Finally, the intended target of a perpetrator may be a student organization or the general Penn State student community. Those numbers of targeted persons cannot be determined.

• The data collection forms were not always similar from campuses and police. Therefore, this statistical account still represents varied information about characteristics of targeted individuals, those who submitted reports, and perpetrators. An effort was made to gain clarification in such instances. A meeting also occurred to rectify this. In the future, efforts will be made to ensure uniformity of data gathered and reported.
